Members,

Below are links to the Legacy Bill Conference committee report. The Outdoor Heritage Fund appropriations and other language is in Article One, Pages 2 through 21. Sandy, Heather and I think the Council's recommendation fared well in this session and each of you should be proud and pleased. There were some changes and additions as there are to all appropriations bills.

In a nutshell all of the recommendations of the Council were funded at the recommended level except the supplemental recommendation for RIM/WRP (\$4.4 million less than final recommendation), Conservation Partners (\$3.0 million more than recommended in AIS related grants), and Council Administration (\$.468 less than recommended or one year of LSOHC administration.) A Metro Park Habitat Grant Program was added (\$6.3 million to Met Council.) Our fund balance was spent down to \$2.057 or 2% of the projected income.

On page and line 20.29 the Council is directed to examine transitioning to a biennial recommendations process beginning with fiscal year 2016. This examination is to be done cooperatively with the House and Senate committees and divisions with jurisdiction over environment and natural resources and the Outdoor Heritage Fund. The results of that study are due January 1, 2014.
